- PHYSICAL/CHEMICAL HAZARDS: Cercosporamide was originally identified as a host-selective phytotoxin and broad, spectrum antifungal agent isolated from Cercosporidium henningsii. More recently, cercosporamide was shown to inhibit a cell wall integrity pathway mediated through a serine/threonine protein kinase, Pkc1, that is central to cell wall biosynthesis. It is both a potent (IC50<50nM) ans selective inhibitor of Pkc1 kinase.
- **HUMAN HEALTH HAZARDS:** To the best of our knowledge, the health hazards of this material have not been fully investigated.
